- Restricted Stock award issued pursuant to the 2013 LTIP. The shares of restricted stock are subject to both time-based and performance-based vesting requirements. The time-based vesting requirements provide that the shares of restricted stock will vest in three equal annual installments beginning on September 1, 2020, subject to satisfaction of the performance-based vesting requirements. The performance-based vesting requirements provide that the shares vest in three equal portions upon achievement of ION common stock reaching twenty (20) day volume weighted average price per share targets of \$17.50, \$22.50 and \$27.50, respectively, on or before September 1, 2022, subject to satisfaction of the time-based vesting requirements.
