The performance-based vesting requirements provide that the shares vest in three equal portions upon achievement of ION common stock reaching twenty (20) day volume weighted average price per share targets of \$17.50, \$22.50 and \$27.50, respectively, on or before March 5, 2023, subject to satisfaction of the time-based vesting requirements.
